GST</p> <p>PIHEA</p>	<p>Would normally be employed in the field and has successfully completed the IHEA Professional Certificate in HFM via the IHEA Log Book Professional. Thereafter retains their membership by completing the Professional Development requirements logged using the IHEA Log Book</p>

GST</p> <p>GIHEA</p>	<p>Would normally be employed in the field and has completed the Diploma of Facilities Management or holds an equivalent qualification (subject to verification). Thereafter retains membership by completing the Professional Development requirements logged using the IHEA Log Book</p>
<p><i>Fellow</i> \$415 Inc. GST OR Complimentary as determined by Board (replaces honorary)</p>	<p>Is a Graduate member who through contribution and distinguished service to the profession and the institute (Log Book Pro at least, and 5 years Institute Membership, plus outstanding contribution)</p>

HC membership is a pro-rated discounted financial arrangement for the administration / payment of membership fees, allowing all relevant staff to be covered under corporate cover with a single invoice provided. Members covered by a HC arrangement will still be assessed / admitted as individual members based on the relevant criteria above.</p>
<p><i>State Corporate</i> \$870</p>	<p>State Corporate Membership is available to companies that have an interest in the Healthcare industry such as Healthcare Networks, Consultants, Contractors, Installers or Suppliers of healthcare FM / engineering-related products or services. This type of membership grade is suited to organisations whose activities are focussed in one or two States. Membership fees are applicable for each nominated State. Membership entitles the company to nominate two (2) individuals in the State of their preference.</p>
<p><i>National Corporate</i> \$3850</p>	<p>National Corporate Membership is available to companies that have an interest in the Healthcare industry such as Healthcare Networks, Consultants, Contractors, Installers or Suppliers of healthcare FM / engineering-related products or services. This type of membership grade is suited to organisations that have a national presence. Membership fees apply on a national basis. National Corporate membership entitles the company to nominate two (2) individuals in each State Branch.</p>
